LegalHealth at Woodhull Hospital

Patient Stories

Ms. F

Ms. F is an undocumented widow in her 80s from Jamaica. Four years ago, her daughter in Jamaica sent her to New York to live with her son and his family. Ms. F's health has deteriorated and she needs continuous care. Her son quit his job to care for his mother full-time, leaving his wife the sole wage earner in their household of six. Ms. F's son told her geriatrician about his lack of finances to continue to care for his mother. At the same time, he was distraught over the care she would receive in Jamaica with his sister who does not want their mother to return. The physician referred Ms. F and her son to the LegalHealth clinic. Ms. F's son learned he was eligible to naturalize since he has been a lawful permanent resident for 5 years. Once that was filed, Ms. F's son filed to adjust his mother's status making her eligible for NY State Medicaid. With Medicaid, she could receive homecare services, and her son could return to work.

Terri

Terri's husband is in prison and she struggles to raise their eight children alone. She is under treatment for mastoiditis, a dangerous ear condition, as well as depression with thoughts of suicide. She also sees a neurologist for her worsening headaches. When her public assistance, including food stamps and housing allowance, was cut in half for failure to comply with public assistance regulations, Terri panicked. Her doctor referred her to LegalHealth, where the attorney went through the paperwork and found that Terri actually was in compliance. She applied for a fair hearing and represented Terri at the hearing. Terri won her appeal and all her benefits were restored. She received a \$2,000 retroactive award and \$641 in monthly benefits were restored.
