## Patient Stories

### *Susie*

Susie, a 26-year-old mother of three living in public housing, was being sued for back rent, despite a perpetually broken refrigerator where all the food, including the family's Thanksgiving dinner, spoiled. Plaster was falling in the living room, and her son's bedroom wall was riddled with holes. An infestation of roaches aggravated his asthma. LegalHealth helped Susie secure a rent discount, a new refrigerator and professional extermination of the roaches.

### *Tamika*

Tamika, an immigrant from Mali, lived in the U.S. for more than three years as an undocumented alien. After she gave birth to a baby girl, Tamika's relatives demanded she return to Mali for the child's circumcision ritual. Fearing her own deportation and the genital mutilation of her baby, Tamika turned to her pediatrician for help. She was referred to LegalHealth, which worked with its immigration colleagues at the New York Legal Assistance Group. Its attorneys filed for her political asylum. After a two-and-a-half-year legal battle, Tamika won. She is free and her little girl is safe from genital mutilation.
